Opening remarks: U.S. – Romania Economic Forum Ionuț Simion, President, AmCham Romania September 28, 2022

- Good morning & welcome everyone!
- In my capacity of President of the American Chamber of Commerce in Romania, it is a great honor to open the U.S. Romania Economic Forum: from Security to Prosperity.
- AmCham Romania joins therefore the high-level initiatives of this year to mark the 25th anniversary of the US Romania Strategic Partnership, focused this time on the economic agenda, where our expertise lies.
- The U.S. Romania Strategic Partnership, that preceded Romania's NATO membership, was an expression of both countries' commitment towards a solid cooperation, and we are grateful for the continued partnership over the past 25 years.

- We need to look no further than Ukraine to understand and **acknowledge the value of Romania's NATO and EU membership.** It is what safeguarded all of us living and working in Romania to go on with our lives, and more than that, to join the Ukraine war relief efforts, as a country, as corporate citizens, as individuals.
- Like many times in history, Ukraine's situation shows that armies can win a battle but to win the war you need a solid and strong economy.
- Therefore, while the geopolitical context called for an intensified security cooperation, and we are grateful for the ongoing support our country receives from its NATO allies, we all agree that it provides a solid foundation for further developing the investment and the economic relations between our two countries, and there is no better time to discuss about and commit to the shared objectives of increasing trade and investments both ways.
- All of us at AmCham are extremely honored to host today's high-level dialogue on the future of U.S. Romania economic relations, and I would like to thank our distinguished keynote speakers, the U.S. and RO officials, the representatives of central and local authorities, the U.S Embassy team, the AmCham Romania members, the business leaders, and the media, that are present here today.

- After a 15 minutes break to allow our keynote speakers leave the stage, the second part of the event will be dedicated to "the policy industry" dialogue, where we have invited members of the Romanian Government and representatives of leading U.S. investors in Romania to engage in a dialogue on what it takes for our country to attract more investments from the U.S.
- To contextualize the discussion, I will start by present some key results of what we believe to be a first attempt to measure the volume and impact of the US RO economic relations, which my colleagues in AmCham has worked with a team of researchers at the Babes Bolyai University in Cluj-Napoca.
- The figures will illustrate the evolution of our commercial relations, the championing industries, and more than that, will reveal the great potential for further growth of our bilateral economic cooperation.
- To conclude, we are aware that this is an ambitious agenda, therefore, today's conference is only the opening of the forum which will be followed by a series of roundtables dedicated to those industries that hold the greatest potential for future economic growth.
