To join the SelectUSA Tech program, a startup **must**

- ✓ be head quartered outside the U.S.
- ✓ develop innovative technology products/services
- ✓ look to the U.S. market for expansions within the next 2-3 years

and **meet at least one** of the following criteria:

- ✓ 0 – 10 years old (founded on or after Jan 1, 2014)
- ✓ 0 – 40 employees
- ✓ USD 0 – 10 million in annual revenue

We invite all tech startups in our community to consider this opportunity and reach out to us for additional information.

SelectUSA Tech also has a dedicated program for international women founders, entrepreneurs, and executives in the tech sector – “**Select Global Women in Tech**” (SGWIT).
