You can **apply online** to attend the Summit, via the dedicated platform (selectusasummit.us). Once the application is successfully submitted, it will be reviewed and approved by SelectUSA. You will be notified by email when your application is approved and the payment will be processed automatically.

The organizers will make **accommodation** available at the Gaylord National Resort and Convention Center, which can be booked by the attendees.
